Dear NCS Parents, Guardians and Staff:

The Northfield Community Schools is committed to protecting our students' and staff's health. As required by the Department of Education regulations, all drinking water outlets in our facilities must be sampled for lead. We have scheduled the lead drinking water sampling for both Northfield Community Schools for Saturday, April 14, 2017.

Why Test School Drinking Water for Lead?

Lead can cause serious health problems if too much enters the body from drinking water or other sources. Lead is most dangerous for pregnant women, infants, and children under 6 years old. Exposure to high levels of lead during pregnancy contributes to low birth weight and developmental delays in infants. In young children, lead exposure can lower IQ levels, affect hearing, reduce attention span, and hurt school performance. At very high levels, lead can even cause brain damage.

Lead is rarely found in the source water; rather it enters the drinking water primarily as a result of the corrosion, or wearing away, of materials containing lead in the service line or interior plumbing. These materials include lead-based solder used to join copper pipe, brass and chromebrass faucets, and in some cases, pipes made of lead that connect buildings to water mains (service lines). Since 1986, all plumbing materials must be "lead free". The law currently allows plumbing materials to be up to 0.25 percent lead to be labeled as "lead free". However, prior to January 4, 2014, "lead free" allowed up to 8 percent lead content of the wetted surfaces of plumbing products including those labeled National Sanitation Foundation (NSF) certified.

What Actions We Are Taking?

Prior to sampling, Northfield Community Schools developed a Lead Sampling Plan for and conducted a plumbing profile. The purpose of the plumbing profile was to identify all drinking water outlets and evaluate the plumbing materials of the school to determine if lead solder, lead pipes or a lead service line are present.

The Northfield Community Schools Lead Sampling Plan may be found on our website at northfield groupfusion.net.

All drinking water outlets in the Northfield Community Schools will be sampled on April 14, 2017. We anticipate receiving the results from our laboratory within 2(two) weeks of sampling. Upon receiving the sample results, Northfield Community Schools will inform you if any of the drinking water outlets had a result greater than the action level of 15 μ g/l (parts per billion [ppb]) and will post all of the results on our website at northfield groupfusion.net. The results will be used to assist in the prioritization of future water testing for lead in accordance with Northfield Community School's Lead Sampling Plan.

Northfield Community Schools will also implement immediate remedial measures for any drinking water outlet with a result greater than the action level of 15 μ g/l (ppb). This will include turning off the outlet unless it is determined the location must remain on for non-drinking purposes. In these cases, a "DO NOT DRINK – SAFE FOR HANDWASHING ONLY" sign will be posted.
